GREETINGS

In the name of the Commonwealth of Massachusetts and pursuant to Section 16B of Chapter 71 of the General Laws of said Commonwealth, you are directed to notify and warn said inhabitants of the Towns of Charlemont and Hawley qualified to vote in elections and in Town affairs, to meet at the Hawlemont Regional School in Charlemont on Saturday, the 28th day of November, 2020 at seven o'clock in the evening to act on the following articles:

Article 1: To see if the Towns will vote to approve the FY-21 Proposed Budget recommended by the Hawlemont Regional School Committee on September 25, 2020, in a total amount of \$2,226,931, and to raise and appropriate, transfer from available funds, or otherwise provide the sums listed below which correspond to each Town's assessment:

For Charlemont:

Operating: \$844,992

Net Capital: \$32,876

Total: \$877,869

For Hawley:

Operating: \$253,770

Net Capital: \$8,271

Total: \$262,040

Article 2: To conduct any other business which may lawfully come before the Meeting.

And you are directed to serve this warrant by posting attested copies thereof in the Town Clerk's office in each Town and in at least two other public places in each Town fourteen days at least before the time of holding said meeting and by publishing a copy of said warrant in at least one newspaper in general circulation within the member municipalities.
